

RoHS Declaration of Compliance

DECLARES THAT

- products belonging to the **arcoPlus®**, **arcoWall®**, **Velario®**, **PoliCarb®**, **PoliComp®**, **Scudo®**, **TegoPlus®** and **TegoLUX®** lines, and related accessories, are RoHS compliant, as it is verified that the substances limited by the Directive 2011/65/EU of the European Parliament and subsequent integrations are not contained in the finished products in concentrations greater than the values listed below, unless the substance is not exempt according to RoHS;
- the limits taken into account are those set out in Annex II to Directive 2011/65/EU, with the amendments made by Delegated Directive (EU) 2015/863 that will become mandatory as of 22/07/2019 (shown in red):
